1. **DATA, HORA E LOCAL:** Realizada em 14 de abril de 2022, às 11:00 horas, na sede social da Raia Drogasil S.A. ("Companhia"), localizada na cidade de São Paulo, Estado de São Paulo, na Avenida Corifeu de Azevedo Marques nº 3.097.
2. **CONVOCAÇÃO E PRESENCAS:** Edital de Convocação publicado nas edições de 12, 14 e 15 de março de 2022 do jornal "O Estado de S. Paulo", nas páginas B6, B5 e B15, respectivamente.
3. **PRESENÇA:** Presentes, na Assembleia Geral Extraordinária, acionistas representando 82,12% do capital votante, e, na Assembleia Geral Ordinária, acionistas representando 81,69% do capital votante, conforme (i) assinaturas apostas na "Lista de Presença de Acionistas" e (ii) boletins de voto a distância, recebidos diretamente na Companhia e por meio do Itaú Corretora de Valores S.A., agente escriturador da Companhia, nos termos da Instrução da Comissão de Valores Mobiliários nº 481/09 ("ICVM nº 481/09"). Presentes, também, membros da administração, do Conselho Fiscal e da Ernest Young Auditores Independentes.
4. **MESA:** Presidente da Mesa: Antonio Carlos de Freitas; e Secretário da Mesa: Elton Flavio Silva de Oliveira.
5. **ORDEM DO DIA:** em **Assembleia Geral Extraordinária:** (i) alteração do Estatuto Social da Companhia para: (i.1) incluir previsão de que acionistas e administradores devem atuar no interesse da Companhia e da sociedade com boas práticas de sustentabilidade, responsabilidade social e governança; (i.2) permitir que as reuniões do Conselho de Administração e da Diretoria sejam secretariadas por pessoa a ser indicada pelo presidente da reunião em questão; (i.3) alterar a alçada de aprovação do Conselho de Administração para certas transações como celebração de contratos, conjunto de ativos permanentes e intangíveis e fundos de comércio; (i.4) ajustar a redação da competência do Conselho de Administração para aprovação de transação com partes relacionadas; (i.5) alterar a alçada de aprovação do Conselho de Administração para orientação de voto em controladas relativo a certas matérias; (i.6) permitir a criação de comissões pelo Conselho de Administração; e (i.7) esclarecer que eventual acumulação de cargo de Diretor(a)-Presidente e membro do Conselho de Administração, em

razão da vacância do cargo de Diretor(a)-Presidente, será temporária; e **(ii)** consolidação do Estatuto Social da Companhia; e em **Assembleia Geral Ordinária**: **(iii)** tomada de contas dos administradores, exame, discussão e votação das demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2021, acompanhadas do Relatório da Administração e do Relatório dos Auditores Independentes, publicados na edição do “O Estado de S. Paulo” em 23 de fevereiro de 2022, bem como do Parecer do Conselho Fiscal; **(iv)** destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2021, referendando as apropriações de juros sobre capital próprio e distribuição de dividendos intermediários previamente deliberadas pelo Conselho de Administração, os quais serão imputados ao dividendo obrigatório; **(v)** fixação da remuneração anual global dos administradores da Companhia; **(vi)** fixação do número de membros que irão compor o Conselho Fiscal da Companhia; **(vii)** eleição dos membros do Conselho Fiscal e respectivos suplentes; e **(viii)** fixação da remuneração dos membros do Conselho Fiscal.

6. **DELIBERAÇÕES**: Após dispensa da leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, de acordo com a ICVM nº 481/09, foram tomadas as seguintes deliberações:

6.1. Registra-se a lavratura da ata destas Assembleias Gerais Ordinária e Extraordinária em forma de sumário, ficando autorizada a sua publicação com a omissão das assinaturas dos acionistas presentes, nos termos do artigo 130 da Lei nº 6.404/76.

Em Assembleia Geral Extraordinária:

- (a) Alterar o Estatuto Social da Companhia, conforme detalhado no Anexo V da Proposta da Administração, de modo a: (a.1) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, incluir o Parágrafo Único no Artigo 3º do Estatuto Social da Companhia, para refletir o compromisso da Companhia em exercer suas atividades em conformidade com as boas práticas de sustentabilidade, responsabilidade social e governança; (a.2) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, incluir o Parágrafo Oitavo no Artigo 5º do Estatuto Social da Companhia, para refletir o compromisso da Companhia em exercer suas atividades em conformidade com as boas práticas de sustentabilidade, responsabilidade social e governança; (a.3) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar o Parágrafo Primeiro do Artigo 7º e do Parágrafo Segundo do Artigo 12 do Estatuto Social da Companhia, para permitir que as reuniões do Conselho de Administração e da Diretoria sejam secretariadas por pessoa a ser indicada pelo presidente da reunião em questão; (a.4) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar a alínea “m)” do

Artigo 8º do Estatuto Social da Companhia, para alterar a alçada de aprovação do Conselho de Administração para celebração de contratos, conjunto de ativos permanentes e intangíveis e fundos de comércio; (a.5) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar a alínea “x)” do Artigo 8º do Estatuto Social da Companhia, a fim de prever que negócios entre partes relacionadas devem atender as diretrizes da Política de Transação entre Partes Relacionadas previamente aprovada pelo Conselho de Administração da Companhia; (a.6) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar a alínea “aa)” do Artigo 8º do Estatuto Social da Companhia, a fim de alterar a alçada de aprovação do Conselho de Administração para orientação de voto em controladas relativo a certas matérias; (a.7) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar o Parágrafo Segundo do Artigo 8º do Estatuto Social da Companhia, a fim de permitir a criação de comissões com funcionamento permanente ou temporário pelo Conselho de Administração; (a.8) por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, alterar o Parágrafo Primeiro do Artigo 10 do Estatuto Social da Companhia, para esclarecer que eventual acumulação de cargo de Diretor(a)-Presidente e membro do Conselho de Administração, em razão da vacância do cargo de Diretor(a)-Presidente, será temporária e pelo prazo máximo de 120 (cento e vinte) dias.

- (b) Aprovar, por unanimidade, tendo sido computados 1.353.172.700 votos a favor e registradas 20.000 abstenções, a consolidação do Estatuto Social da Companhia para contemplar as deliberações tomadas nesta assembleia, o qual passa a fazer parte integrante da ata que se refere à presente assembleia como Anexo I.

Em Assembleia Geral Ordinária:

- (c) Aprovar, sem reservas, por maioria, tendo sido computados 1.190.210.912 votos a favor e 1.043.800 votos contrários e registradas 154.797.912 abstenções, as contas dos administradores e as demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2021, acompanhadas do Relatório da Administração e do Relatório dos Auditores Independentes, publicados na edição do “O Estado de S. Paulo” em 23 de fevereiro de 2022, e do Parecer do Conselho Fiscal;
- (d) Aprovar, por unanimidade, tendo sido computados 1.346.032.624 votos a favor e registradas 20.000 abstenções, a destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2021, no valor de R\$ 751.934.421,37 (setecentos e cinquenta e um milhões, novecentos e trinta e quatro mil, quatrocentos e vinte e um reais e trinta e sete centavos), somado ao valor decorrente da realização da Reserva de

Reavaliação, no montante de R\$ 162.182,76 (cento e sessenta e dois mil, cento e oitenta e dois reais e setenta e seis centavos), e aos dividendos prescritos em 2021, no montante de R\$ 586.048,60 (quinhentos e oitenta e seis mil, quarenta e oito reais e sessenta centavos), totalizando o valor a ser destinado de R\$ 752.682.652,73 (setecentos e cinquenta e dois milhões, seiscentos e oitenta e dois mil, seiscentos e cinquenta e dois reais e setenta e três centavos), nos termos da Proposta da Administração e considerando as previsões legais e estatutárias, conforme segue: **(i)** R\$ 37.596.721,07 (trinta e sete milhões, quinhentos e noventa e seis mil, setecentos e vinte e um reais e sete centavos), equivalente a 5% (cinco por cento) do lucro líquido do exercício, para a Reserva Legal; **(ii)** R\$ 205.000.000,00 (duzentos e cinco milhões de reais) aos acionistas, equivalentes ao montante total bruto de juros sobre o capital próprio apropriados em 2021 declarados nas Reuniões Extraordinárias do Conselho de Administração de *(ii.1.)* 05 de março de 2021, no valor bruto de R\$ 44.000.000,00 (quarenta e quatro milhões de reais), correspondente à R\$ 0,026664992 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pago aos acionistas em 01 de dezembro de 2021, *(ii.2.)* 18 de junho de 2021, no valor bruto de R\$ 50.000.000,00 (cinquenta milhões de reais), correspondente à R\$ 0,030300099 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pago aos acionistas em 08 de dezembro de 2021, *(ii.3)* 09 de novembro de 2021, no valor bruto de R\$ 53.000.000,00 (cinquenta e três milhões de reais) correspondente à R\$ 0,03217660180 por ação, sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, a ser pago aos acionistas até 31 de maio de 2022 sem acréscimo de correção monetária ou juros, e *(ii.4.)* 03 de dezembro de 2021, no valor bruto de R\$ 58.000.000,00 (cinquenta e oito milhões de reais), correspondente à R\$ 0,03521213027 por ação, sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, a ser pago aos acionistas até 31 de maio de 2022 sem acréscimo de correção monetária ou juros; **(iii)** a distribuição de dividendos intermediários previamente deliberada pelo Conselho de Administração em reuniões extraordinárias de *(iii.1)* 09 de novembro de 2021, no valor bruto de R\$120.000.000,00 (cento e vinte milhões de reais), correspondente à R\$ 0,07285268332 por ação, sobre o qual não será efetuada a dedução do imposto de renda na fonte, pago aos acionistas em 01 de dezembro de 2021; e *(iii.2)* 03 de dezembro de 2021, no valor bruto de R\$ 41.000.000,00 (quarenta e um milhões de reais), correspondente à R\$ 0,024891333 por ação, sobre o qual não é efetuada a dedução do imposto de renda na fonte, pago aos acionistas em 15 de dezembro de 2021; totalizando o valor bruto de R\$ 366.000.000,00 (trezentos e sessenta e seis milhões de reais) e o valor líquido de R\$ 338.854.125,82 (trezentos e trinta e oito milhões, oitocentos e cinquenta e quatro mil, cento e vinte e cinco reais e oitenta e dois centavos); **(iv)** R\$ 91.599.908,61 (noventa e um milhões, quinhentos e noventa e nove mil, novecentos e oito reais e sessenta e um centavos) para a Reserva de Incentivos Fiscais, nos termos do artigo 195-A da Lei nº 6.404/76; e

(v) R\$ 257.486.023,05 (duzentos e cinquenta e sete milhões, quatrocentos e oitenta e seis mil, vinte tres reais e cinco centavos), para a Reserva Estatutária prevista no Artigo 21, alínea “c”, do Estatuto Social da Companhia;

- (e) Aprovar, por maioria, tendo sido computados 1.339.292.561 votos a favor e 3.744.088 votos contrários e registradas 3.015.975 abstenções, em conformidade com o §4º do artigo 5º do Estatuto Social da Companhia, a remuneração global anual dos membros do Conselho de Administração e da Diretoria da Companhia para o exercício social de 2022, no valor total líquido de até R\$ 60.240.320,00 (sessenta milhões, duzentos e quarenta mil, trezentos e vinte reais);
- (f) Eleger os seguintes membros efetivos e respectivos suplentes para o Conselho Fiscal da Companhia, para mandato de 1 (um) ano que se encerrará na Assembleia Geral Ordinária a ser realizada em 2023:
