1. **DATA, HORA E LOCAL:** Realizada em 30 de abril de 2021, às 10:30 horas, na sede social da Raia Drogasil S.A. ("Companhia"), localizada na cidade de São Paulo, Estado de São Paulo, na Avenida Corifeu de Azevedo Marques nº 3.097.
2. **CONVOCAÇÃO E PRESENCAS:** Edital de Convocação publicado nas edições de 31 de março, 1º e 6 de abril de 2021 do Diário Oficial do Estado de São Paulo, nas páginas 285, 132 e 116, respectivamente, e do jornal "O Estado de S. Paulo", nas páginas B8, B14 e B10, respectivamente.
3. **PRESENÇA:** Presentes, na Assembleia Geral Extraordinária, acionistas representando 81,72% do capital votante, e, na Assembleia Geral Ordinária, acionistas representando 78,62% do capital votante, conforme (i) assinaturas apostas na "Lista de Presença de Acionistas" e (ii) boletins de voto a distância, recebidos diretamente na Companhia e por meio do Itaú Corretora de Valores S.A., agente escriturador da Companhia, nos termos da Instrução CVM nº 481/09. Presentes, também, membros da administração, do Conselho Fiscal e da Ernest Young Auditores Independentes.
4. **MESA:** Presidente da Mesa: Renato Pires Oliveira Dias; e Secretário da Mesa: Antonio Carlos de Freitas.
5. **ORDEM DO DIA:** em **Assembleia Geral Extraordinária:** (i) alteração do Estatuto Social da Companhia para: (i.1) explicitar que os membros do Conselho de Administração poderão outorgar procuração para que outro membro do mesmo órgão o represente na reunião; (i.2) alterar a composição do Conselho de Administração para o mínimo de 11 e o máximo de 13 membros; (i.3) excluir a necessidade de eleição de suplentes para o Conselho de Administração; (i.4) incluir vedação para a acumulação dos cargos de Diretor e de membro do Conselho de Administração da Companhia; (i.5) excluir a previsão de que membros suplentes do Conselho de Administração devem substituir os titulares em caso de vacância; (i.6) incluir que a eleição e destituição do Presidente e Vice-Presidente do Conselho de Administração serão competência do próprio Conselho; (i.7) incluir previsão de que, na vacância do cargo de conselheiro, o próprio Conselho de Administração elegerá o seu substituto para terminar o

mandato; (i.8) criar o cargo de Vice-Presidente do Conselho de Administração e definir suas atribuições; e (i.9) tornar o Conselho Fiscal da Companhia um órgão permanente; e (ii) consolidação do Estatuto Social da Companhia; e em **Assembleia Geral Ordinária**: (iii) tomada de contas dos administradores, exame, discussão e votação das demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2020, acompanhadas do Relatório da Administração e do Relatório dos Auditores Independentes, publicados na edição do Diário Oficial do Estado de São Paulo nas páginas 40 à 58 e “O Estado de S. Paulo” em 10 de março de 2021 nas páginas 1 a 14, bem como do Parecer do Conselho Fiscal; (iv) destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2020, referendando as apropriações de juros sobre capital próprio previamente deliberadas pelo Conselho de Administração, os quais serão imputados ao dividendo obrigatório; (v) determinação do número de membros a compor o Conselho de Administração da Companhia; (vi) eleição dos membros efetivos do Conselho de Administração; (vii) fixação da remuneração anual global dos administradores da Companhia; (viii) fixação do número de membros que irão compor o Conselho Fiscal da Companhia; (ix) eleição dos membros do Conselho Fiscal e respectivos suplentes; e (x) fixação da remuneração dos membros do Conselho Fiscal.

6. **DELIBERAÇÕES**: Após dispensa da leitura do mapa de votação consolidado dos votos proferidos por meio de boletins de voto a distância, o qual ficou à disposição para consulta dos acionistas presentes, de acordo com a Instrução da Comissão de Valores Mobiliários (“CVM”) nº 481/09, foram tomadas as seguintes deliberações:

6.1. Foi autorizada a lavratura da ata dessas Assembleias Gerais Ordinária e Extraordinária em forma de sumário, bem como sua publicação com omissão das assinaturas dos acionistas presentes, nos termos do artigo 130 da Lei nº 6.404/76.

Em Assembleia Geral Extraordinária:

- (a) Alterar o Estatuto Social da Companhia, conforme detalhado no Anexo V da Proposta da Administração, de modo a: (a.1) por maioria, tendo sido computados 1.345.040.098 votos a favor e 663.655 votos contrários e registradas 4.219.061 abstenções, explicitar que os membros do Conselho de Administração poderão outorgar procuração para que outro membro do mesmo órgão o represente na reunião; (a.2) por maioria, tendo sido computados 1.297.390.241 votos a favor e 48.313.512 votos contrários e registradas 4.219.061 abstenções, alterar a composição do Conselho de Administração para o mínimo de 11 e o máximo de 13 membros; (a.3) por maioria, tendo sido computados 1.332.031.359 votos a favor e 13.672.394 votos contrários e registradas 4.219.061 abstenções, excluir a necessidade de eleição de suplentes para o Conselho de Administração; (a.4) por maioria, tendo sido computados 1.345.153.898 votos a favor e 549.855 votos contrários e registradas 4.219.061 abstenções, incluir vedação para a

acumulação dos cargos de Diretor e de membro do Conselho de Administração da Companhia; (a.5) por maioria, tendo sido computados 1.332.031.359 votos a favor e 13.672.394 votos contrários e registradas 4.219.061 abstenções, excluir a previsão de que membros suplentes do Conselho de Administração devem substituir os titulares em caso de vacância; (a.6) por maioria, tendo sido computados 1.345.153.898 votos a favor e 549.855 votos contrários e registradas 4.219.061 abstenções, incluir que a eleição e destituição do Presidente e Vice-Presidente do Conselho de Administração serão competência do próprio Conselho; (a.7) por maioria, tendo sido computados 1.332.031.359 votos a favor e 13.672.394 votos contrários e registradas 4.219.061 abstenções, incluir previsão de que, na vacância do cargo de conselheiro, o próprio Conselho de Administração elegerá o seu substituto para terminar o mandato; (a.8) por maioria, tendo sido computados 1.345.153.898 votos a favor e 549.855 votos contrários e registradas 4.219.061 abstenções, criar o cargo de Vice-Presidente do Conselho de Administração e definir suas atribuições; (a.9) por maioria, tendo sido computados 1.335.542.178 votos a favor e 10.161.575 votos contrários e registradas 4.219.061 abstenções, tornar o Conselho Fiscal da Companhia um órgão permanente.

- (b) Aprovar, por maioria, tendo sido computados 1.345.153.898 votos a favor e 549.855 votos contrários e registradas 4.219.061 abstenções, a consolidação do Estatuto Social da Companhia para contemplar as deliberações tomadas nesta assembleia, o qual passa a fazer parte integrante da ata que se refere à presente assembleia como Anexo I.

Em Assembleia Geral Ordinária:

- (c) Aprovar, sem reservas, por maioria, tendo sido computados 1.115.946.952 votos a favor e 358.965 votos contrários e registradas 182.462.679 abstenções, as contas dos administradores e as demonstrações financeiras relativas ao exercício social encerrado em 31 de dezembro de 2020, acompanhadas do Relatório da Administração e do Relatório dos Auditores Independentes, publicados na edição do Diário Oficial do Estado de São Paulo e “O Estado de S. Paulo” em 10 de março de 2021, bem como do Parecer do Conselho Fiscal.
- (d) Aprovar, por unanimidade, tendo sido computados 1.294.549.535 votos a favor e registradas 4.219.061 abstenções, a destinação do lucro líquido do exercício social encerrado em 31 de dezembro de 2020, no valor de R\$ 484.443.639,34 (quatrocentos e oitenta e quatro milhões, quatrocentos e quarenta e três mil, seiscentos e trinta e nove reais e trinta e quatro centavos), somado ao valor decorrente da realização da Reserva de Reavaliação, no montante de R\$ 171.527,38 (cento e setenta e um mil, quinhentos e vinte e sete reais e trinta e oito centavos), e aos dividendos prescritos em 2020, no

montante de R\$ 573.094,37 (quinhentos e setenta e três mil, noventa e quatro reais e trinta e sete centavos), totalizando o valor a ser destinado de R\$ 485.188.261,09 (quatrocentos e oitenta e cinco milhões, cento e oitenta e oito mil, duzentos e sessenta e um reais e nove centavos), nos termos da Proposta da Administração e considerando as previsões legais e estatutárias, conforme segue: **(i)** R\$ 24.222.181,97 (vinte e quatro milhões, duzentos e vinte e dois mil, cento e oitenta e um reais e noventa e sete centavos), equivalente a 5% (cinco por cento) do lucro líquido, para a Reserva Legal; **(ii)** R\$ 193.000.000,00 (cento e noventa e três milhões de reais) aos acionistas, equivalentes ao montante total bruto de juros sobre o capital próprio apropriados em 2020 declarados nas Reuniões Extraordinárias do Conselho de Administração de *(ii.1.)* 23 de março de 2020, no valor bruto de R\$ 47.000.000,00 (quarenta e sete milhões de reais), correspondente à R\$ 0,142477170 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pago aos acionistas em 03 de dezembro de 2020, *(ii.2.)* 04 de junho de 2020, no valor bruto de R\$ 49.000.000,00 (quarenta e nove milhões de reais), correspondente a R\$ 0,148540028 por ação, sobre o qual é efetuada a dedução do imposto de renda na fonte, conforme aplicável, pago aos acionistas em 03 de dezembro de 2020, *(ii.3)* 17 de setembro de 2020, no valor bruto de R\$ 50.000.000,00 (cinquenta milhões de reais) correspondente a R\$ 0,030314292 por ação, sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, a ser pago aos acionistas até 31 de maio de 2021 sem acréscimo de correção monetária ou juros, e *(ii.4)* 11 de dezembro de 2020, no valor bruto de R\$ 47.000.000,00 (quarenta e sete milhões de reais), sobre o qual será efetuada a dedução do imposto de renda na fonte, conforme aplicável, correspondente a R\$ 0,028494338 por ação, a ser pago aos acionistas até 31 de maio de 2021 sem acréscimo de correção monetária ou juros; totalizando o valor bruto de R\$ 193.000.000,00 (cento e noventa e três milhões de reais) e o valor líquido de R\$ 167.163.833,77 (cento e sessenta e sete milhões, cento e sessenta e três mil, oitocentos e trinta e três reais e setenta e sete centavos); **(iii)** R\$ 69.650.169,83 (sessenta e nove milhões, seiscentos e cinquenta mil, cento e sessenta e nove reais e oitenta e três centavos) para a Reserva de Incentivos Fiscais, nos termos do artigo 195-A da Lei nº 6.404/76; e **(iv)** R\$ 198.315.882,29 (cento e noventa e oito milhões, trezentos e quinze mil, oitocentos e oitenta e dois reais e vinte e nove centavos), para a Reserva Estatutária prevista no Artigo 21, alínea “c”, do Estatuto Social da Companhia.

7. **ENCERRAMENTO:** Nada mais havendo a tratar, foi lavrada a presente ata que, depois de lida e aprovada, foi assinada pelos membros da Mesa e pelos acionistas presentes.
